Annual Report of the Executive Board Annual Meeting May 5-6, 2023

The Executive Board of the Florida State Association of Parliamentarians met monthly throughout the year using the Zoom platform. Meetings were well attended.

The dates for the successful "5th Tuesday" series were established for 2023: January 31, May 30, August 29, and October 31. Speakers will be chosen without regard to unit membership.

Barbara Proctor has continued her FSAP Weekly Muse questions that cause members to research and provide written support, including specific Robert's Rules of Order reference information, in answering a particular parliamentary question.

The plans for a cruise experience for FSAP members was, at this time, cancelled.

Over the course of several meetings, it was determined that the FSAP Annual Meeting be held on May 5-6 at the Holiday Inn /St. Petersburg/Clearwater Airport Hotel. The training sessions will be held from 1 PM until 5 PM on Friday, May 5. The format of the annual meeting is hybrid, though almost all of the speakers will be available through Zoom only. The board was presented with a list of the guest speakers for the annual meeting. Julie Palm, meeting planner, is handling the arrangements for the meeting. Ann Guiberson and other executive board members were involved in the proper advertising of the annual meeting to complement the detailed website descriptions of the speakers and their presentations.

Monthly treasurer and membership reports were provided during the year. It was decided that after installation of new officers, a surety bond would be purchased to cover the president and the treasurer.

The bylaws revision work was a major focus of the executive board which planned and implemented the distribution of the draft of the Articles of Incorporation, the revision bylaws, and the revision of the standing ules. A town hall meeting enabled FSAP members to make suggestions, listen to rationale, and ultimately provide amendments for these documents. The executive board supported the need for an attorney for assistance with the review of the Articles of Incorporation. The adoption of these documents was completed at the April 24 meeting of the FSAP membership.

Florida State Association of Parliamentarians President's Report

It was just **729 days** ago that I was elected President of this wonderful organization. For years I have been attending the FSAP May and October meetings, but I never thought that I would run for office, let alone dream of being elected.

The past **104 weeks and one day** flew by. At the first meeting of the Executive Board on the Wednesday after the 2021 Annual meeting, every board member agreed to meet on the second Wednesday of each month. We met *over* 24 times.

During those **17,496 hours**, training sessions were increased to include the 5th Tuesday Zoom events and additional training sessions at the Annual May Meeting and the fall Henry M. Robert Day Meeting. The Florida Parliamentarian moved from a quarterly newsletter to monthly to make sure that you, as members, were provided information more frequently and in a more friendly, easy to read format. And the FSAP Muse, developed by Barbara Proctor, was sent out weekly to encourage you to apply the information found in RONR to real life parliamentary situations.

While we had **1,049,760 minutes**, it was wisely put to use internally. The Executive Board presented revised and amended the Articles of Incorporation at the April 24th Special Meeting. The FSAP Bylaws Committee, which included most of the Executive Board and was represented by all of the Florida units except one, met almost every Monday evening since July of 2022, from 8:30 pm to 10:00 pm. The task was to work on a revision of the FSAP Bylaws and Standing Rules to present to the membership. When completed (4th draft) the committee offered two Town Hall meetings for members to review and offer input. The Special Meeting on April 24th was called to approve: the revised and amended Articles of Incorporation, revision of the Bylaws, Standing Rules, and a Special Rule of Order. In case you missed the meeting, it lasted five and a half hours with one short recess. At <u>12:32 am</u> on April 25th, the mission was accomplished!

As I look back over those **62,985,600 seconds**, I can safely say that the FSAP members were committed to putting all of those seconds to good use.

Thank you for a productive, educational, and fun **two years**.

Report of the FSAP Bylaws Committee on the Revision of the Bylaws and Standing Rules and Special Rule of Order

The FSAP Bylaws Committee submits the following report on its completion of the revision of the bylaws, the standing rules of order, and the special rule of order.

Upon the adoption of a motion in accord with FSAP Bylaws Article IX Committees, Section 2B3, the membership at the 2022 annual membership meeting authorized the committee to draft a revision of the FSAP bylaws.

Additional committee member appointments by the FSAP president expanded the committee membership to twelve, not counting the president who is ex-officio a member. The members (and their unit memberships) are Edward Nelson, PRP, chairman, (Broward-Palm Beach Parliamentarians); Carol Austin, PRP, (Florida Alpha Parliamentarians); Sondra Cofield (Central Florida Parliamentarians), Barbara Davis, RP, (Charlotte County Parliamentarians); Joyce Gleason, RP, (Charlotte County Parliamentarians); Mary Lou Harden, PRP, (Florida Alpha Parliamentarians); Julie Palm, PRP, (Plato Parliamentary Law); Pat Patterson, (Florida Delta Unit of Parliamentarians); Karen Price, (Bradenton Unit); Barbara Proctor, PRP, (Broward-Palm Beach Parliamentarians); Patricia Renau, (Jacksonville Procedure Parliamentary Study Group); Sarah Russell, RP, (Miami Parliamentary Law Unit); and FSAP President Stephanie King, PRP, ex-officio, (Charlotte County Parliamentarians).

The committee recommends adoption of the bylaws revision for the present bylaws and with the proviso that, upon adoption, the bylaws revision shall become effective on the date at which the amended and restated articles of incorporation are filed as evidenced by the Florida Department of State's date and time endorsement on the original document.

The committee recommends adoption of the standing rules revision for the present standing rules.

The committee recommends adoption of the special rule of order, "The name of the maker of a motion shall be omitted from the minutes of all meetings."


The *Florida Parliamentarian* is the primary method of communication with FSAP members. Since the annual meeting in May 2022, the following items have been published:


Florida Parliamentarian overall open rate: 58% Industry average for nonprofits: 17%


Since the annual meeting, a slide show was added to the front page. This colorful feature features pictures of past meetings and information about upcoming meetings. Pages on the website include:

Broward Palm Beach Parliamentarians

June 2022-May 2023

At five years past the name change to Broward-Palm Beach Parliamentarians heralding the unit's geographical expansion, we could never have imagined a more dramatic reach than that brought about by the emergence of a rapidly maturing virtual communications applications industry fueled by the disruptive nature of the pandemic of 2019. Seventeen percent of our Florida members reside outside Broward and Palm Beach counties and another nineteen percent of our members reside outside the state of Florida. Through the work of vice-president and membership committee chairman and primary member, Gloria Bailey, new member recruitment and existing member retention has significantly increased membership from the immediate prepandemic year of approximately twenty members to forty members as of March 1, 2023.

The unit's continuing commitment to the goals of promoting the study of parliamentary procedure and the educational programs of NAP is forever in renewal through the work of educational committee chairman, Dorothy Simmons-Blake RP, expanding our monthly meeting educational programs to include presentations from members of NAP associations and units beyond our regional division. The yearbook was published in color and copies were mailed to the members.

Secretary and primary member Karen Fernander's efforts to recover and post many previous year's minutes to the unit's Google Drive share now makes available to the membership complete annual minutes for the years 2013 through 2022. Karen's diligence in accurately recording meeting minutes and her commitment to fulfilling the duties of secretary has set a standard of excellence for future secretaries to emulate.

Treasurer and primary member, Darlene Sparks, continues to provide monthly financial statements to keep the members well informed on the unit's financial status. IRS form 990N filings are current and the unit's provisional member dues payments to FSAP are current.


